1 INTRODUCTION

The National Treatment Agency (NTA) is a special health authority which aims to improve the availability, capacity and effectiveness of drug treatment in community and prison settings in England. Its key functions will transfer to Public Health England (PHE) by April 2013 and it will cease to exist as a separate organisation. During the interim period the NTA will drive the transformation from a treatment to a recovery system in line with the government's 2010 drug strategy.

The National Drug Treatment Monitoring System (NDTMS) is at the heart of the existing system and is central to the new local authority led system. NDTMS data helps drug treatment demonstrate the outcomes it achieves for the people it treats and in doing so aids accountability for the money invested in it. As part of efforts to improve prison drug treatment, the implementation of a prison specific version of the NDTMS is well underway and is anticipated to go live across the prison estate in England from April 2012.

This document establishes the Reference Data in use within NTA in support of these objectives – for example, in supporting relevant computer systems.

Reference data is defined as (relatively) static data. Generally, it is employed as a means of validating data entry, and will typically be used to control the contents of drop-down lists etc.

All reference data items are applicable to Young People and Adults within community provider settings or Prison establishments unless specified otherwise.

This document is intended to be a definitive and accessible source for use, primarily by NTA personnel. It is not intended to be read from end to end, rather as a reference document, which is utilised by a variety of readerships, including:

- Interpreters of data provided from NTA systems
- Suppliers of systems to NTA
- Suppliers of systems which interface to NTA-systems
- NTA/National Drug Treatment Monitoring System (NDTMS) personnel.

2 CHANGE CONTROL

As this document is the ultimate definition for NDTMS reference data, three consequences follow:

- The behaviour of the NDTMS system must strictly adhere to the latest approved version of this document.
- Only the latest approved version of this document has any significance.
- The person who is performing the role of NDTMS Programme Manager can only make approval of new versions of this document.

For those data items defined by the NTA (internal data), the details contained in this document are the master definitions of such data, extending to issues such as upper/lower case, hyphenation, punctuation etc.

For those data items not defined by the NTA (external data), this document defines the owner of the master data, and any timing details of when changes in such external data are adopted by NDTMS.

For example, the Office for National Statistics (ONS) may up-issue the Ethnicity Codes, but it may not suit the NTA if these new values were to be suddenly and uncontrollably adopted by the NTA, and so the NDTMS Programme Manager needs to control the timing of when this new version of the Ethnicity Codes were to be introduced.

3 TREATMENT OUTCOME PROFILES (TOP)

The TOP was developed as a clinical outcome-monitoring tool suitable for drug misuse treatment.

Because there is not the same professional consensus that TOP is an equally suitable clinical outcome tool for alcohol treatment, TOP returns have never been required within the National Alcohol Treatment Monitoring System (NATMS) guidance, even though the option to provide such returns was made available to practitioners.

The data that has been provided at a national level to date will be analysed to make use of any learning from the returns, although this dataset cannot be validly analysed down to a local level.

5.4 Agency codes

Each treatment provider or Prison establishment is assigned with an Agency Code. Responsibility for allocating a code is the responsibility of the relevant NDTMS manager

A general guideline is that the code should comprise of two parts:

- A single letter which is intended to indicate the NTA Region which 'manages' that agency or prison establishment – see above
- An identifier (one to six alphanumeric characters) which uniquely identifies that treatment provider, within the region.

This guideline will ensure uniqueness of the Agency code on a national basis.

As at Sept 2004, two regions had exceptions to this convention:

- East Midlands region has a small number of agencies beginning with P (i.e. the South East code) – these were originally part of the South East region, but which were later 'moved' due to a boundary re-arrangement.
- North West region's usage of agency codes has an idiosyncrasy - the character 'M' is used for Merseyside agencies.

As the scope of treatment providers included in NDTMS increased (e.g. inclusion of EMIS GPs), it is envisaged that additional coding strategies for Agency codes will be adopted – where these strategies fall outside the general guideline, the NTA Region will need to liaise with NTA to ensure that agency codes are not duplicated on a national basis.

Examples of agency codes include L43, W1019 and UAR1
